We initially sent out a survey to gather information and we are now conducting brief interviews with water utility personnel to get a more in-depth understanding of these topics. Would you be willing to have a conversation with us either now or to be scheduled sometime soon?

IF THE PERSON YOU REACH INDICATES THEY ARE NOT THE RIGHT PERSON TO DO AN INTERVIEW LIKE THIS ASK THE FOLLOWING: If you are not the correct person to participate in an interview on funding, can you let me know the name and contact information of the person who would be in a better position to answer our questions?

Thank you for taking the time to talk with me about your water system. The goal of this interview is two-fold: 1) to dig a little deeper into how you choose funding sources for your public water system, and 2) to better understand the positive and negative aspects of applying for funding.

Ok... a few things before we get started:

#### 1. Consent

I need to receive your verbal consent to participate in this research. We will use content and possibly quotes from our conversation in reports and publications, but everything will be anonymous. Nothing will be able to be traced back to you or your drinking water system.

We will be delivering the results of this research to the funder, the Water Foundation, and the New Mexico legislature; we might include quotes from you or others we interview but will not use your name, title, name of the public water system you manage or any other identifying information in order to ensure anonymity. All of the information we gather from both the survey and these interviews will remain anonymous in all reports resulting from this study and will not be shared with anyone outside our organization.

If you would like a copy of the consent form, we can send you the consent form via mail or email.

I will be taking notes, and if it is alright with you, I would like to record our conversation. The recording will not be shared with anyone outside of our organization. If you are not okay with recording the conversation, I will just take notes.

# **SECTION 1: Characterizing your system**

- 1.1 Before we talk about funding for your water system, for context, can you tell me a bit about you?
  - (15) Your title/role (please provide all the roles you serve if it is more than one)
  - (16) How long have you been involved with or worked for this system? Have you ever worked for any other water system?
  - (17) How many hours per week do you work at the water utility?
  - (18) Do you live within the boundaries of the water system?
  - (19) What is your background related to water utilities (i.e., water training/experience)? If water is not your primary job, do you mind sharing what your main job is?

1.2 (20) Please characterize your system in terms of the age of the infrastructure, the number of people who work or volunteer for the system, and its organizational structure.

### SECTION 2. Choose funding sources for your public water system

#### Now we're going to move on to funding for your water system.

- (26) Follow-up: Do you use any particular resources or technologies to help you find funding sources?
- 2.2 (27) Have you had <u>assistance in completing the grant</u>/funding applications?
  - (28) If yes: Who (individuals, organizations, etc.) helps you complete applications?
  - (29) If no: Is this something you would find useful? Are there any specific types of help you would want?
- 2.3 (30) Have you ever been encouraged to apply for specific resources? For example, did someone from a state agency or an engineer or assistance provider tell you to apply for one particular source or another?
  - (31) If yes, can you indicate which entities provided this information and anything about the context in which this took place? (e.g., during a meeting or an engineer offered to help fill out an application)
- 2.4 (32) Do you have concerns about how the drought might affect your water system? If so, how are you managing those concerns or what types of actions will you have to take?
  - (33) Follow-up: Do any of them involve funding? Do you think there are sufficient funding sources to address drought issues at your system?

### Section 3. The positive and negative aspects of applying for funding

    - receiving the award
    - fund management following receipt of the award
    - Any other part (please specify)
  - (41) Follow-up: Which specific activity within these parts of the process did you find the most challenging?

# New Mexico Drinking Water Finance and Management Study Consent to Participate in Research

**Purpose of the research:** You are being asked to participate in a research project that is being done by Southwest Environmental Finance Center. You are being asked to join because you play a managerial role in your community drinking water system that has been selected to be part of this research.

This consent form contains important information about this project and what to expect if you decide to participate. Please consider the information carefully. Feel free to ask questions before making your decision whether or not to participate. Your participation in this research is voluntary.

## **Key information for you to consider:**

- This project will attempt to determine how drinking water systems in New Mexico interact with funding mechanisms.
- For this research you will be asked to partake in a semi-structured interview with the researchers. This interview will be anonymous and will be recorded and transcribed.
- There are no foreseen risks in partaking in this research. There are also no immediate benefits. The only benefit will be to help further the study of water systems.
- The interviews will take time out of your day. The interviews are estimated to last one hour, but you should account for the possibility that the entire process may take up to two hours.

What you will do in the project: For this project, you will be interviewed by researcher Tucker Colvin or joni palmer. These interviews will be anonymous. The format will be semi-structured. There will be a number of specific questions that deal with the organizational structure of your system, the source water, how you protect source water, and what your perceived risk are. You can decide to not answer any question and can stop the interview at any time. The interviews will be audio recorded and later transcribed.

**Risks:** The only risk for your participation in this study is the inconvenience of taking time out of your day to participate.

**Benefits:** There will be no immediate benefits to you. The overall research will hopefully help water systems in general.

Confidentiality of your information: Everything discussed in the interview will be anonymous and we will take steps to ensure your confidentiality and privacy. Once the interviews are transcribed, the audio files will be destroyed. If the interview takes place using Zoom or another platform that includes video, the video file will be immediately deleted and not stored on any device, only the audio will be saved. The transcriptions will be de-identified from your personal information and stored on a password protected hard drive. Only the research team will have access to the data. Any works published using this research will be anonymous and not contain any identifiable information.

We will take measures to protect the security of all your personal information, but we cannot guarantee confidentiality of all research data. Your name will not be used in any published reports about this research.

**Use of your information for future research:** Your information collected for this project will NOT be used or shared for future research, even if we remove the identifiable information like your name or date of birth.

**Payment:** You will not be paid for participating in this project, but for your participation you will be given a \$20 gift card to either Amazon, Walmart, or Home Depot.

**Right to withdraw from the research:** Your participation in this research is completely voluntary. You have the right to choose not to participate or to withdraw your participation at any time without penalty. If you decide to withdraw from participation, all data obtained from the interview will be destroyed.
